- 1. Photo Id
- 2. Employment letter on employer's letterhead verifying:
  - a) Length of employment
  - b) Annual Income for the past 2 years (include any bonus, rental allowance or other extra income)
  - 3. Copy of your 2 most recent pay stubs
  - 4. If employed less than 2 years, provide prior W2, tax return or employment letter from your prior employer
  - 5. 2 most recent bank statements
  - 6. Letter of reference from your landlord
  - 7. Pet photo and a vet letter if applicable

### B. If you are self-employed or commission based:

- 1. Photo Id
- 2. Letter from your accountant verifying:
  - a) Length of employment, type of business
  - b) Annual income for the past 2 years
- Copy of your complete federal income tax return from the past year (including all schedules, W2 & 1099 forms)
- 4. 2 most recent bank statements
- 5. Letter of reference from your landlord
- 6. Pet photo and a vet letter if applicable

#### c. Guarantor Requirements ( at least 70 X monthly rent):

- 1. Income requirement \$\_\_\_\_\_
- 2. All items listed in A or B above

#### D. Non US resident Applicant :

If the applicant is a new hire, we will ask for 2 months security and a letter of employment advising on the length of the assignment
